CONSUMER UPDATE

Checking your Blood Pressure

To get an accurate reading:

- Be sure that you have emptied your bladder, a full bladder can affect the reading.
- Avoid smoking, drinking anything caffeinated and exercising for at least thirty minutes before the test.
- Keep your feet on the floor for five minutes prior to the test.
- 4. During the test keep still and rest your arm on a table so that it is at heart level.

Diabetics and Diet Soda

If you give up high-fructose corn syrup (HFCS) which is found in most non-diet sodas, don't switch to diet soda. Diet sodas actually can cause weight gain by boosting insulin production.

A study published in <u>Diabetic Care</u> found that drinking diet soda every day increased the risk of type 2 diabetes by as much as 67%.

If you crave sweet bubbly beverages, pour one inch of pure fruit juice in a glass and then fill it with carbonated water.

Insurance 'Deal' Might Cost you More

If you are an AARP member you are always hearing or seeing pitches for insurance. There is nothing wrong with the insurance, but it may not necessarily be the best deal for you. To form a marketing relationship with you, insurers pay royalties or fees, which "produce substantial revenues for the sponsor." Before you jump into getting insurance because an association sponsors it, you should not assume that this is the best deal. Comparison shop or contact the state's insurance agency. This can be done online.

By-Laws Changes to be voted on at September 8th Meeting

The following is a summary of the changes that the By-Laws Committee proposed with modifications made by the Executive Board of AARSPA. After each proposed change is the recommendation of the Executive Board:

Amendment 1

Article II, Section 1c – Purpose - [Change the wording to correct an incorrect title]

"Anne Arundel County Public Schools Retirement/Pension Systems **to** Maryland State Retirement and Pension System."

The Executive Board recommends the APPROVAL of Amendment 1.

Amendment 2

Article III, Section 1a – Membership - [Change the wording to correct an incorrect title]

"Maryland State Teachers Retirement/Pension System to Maryland State Retirement and Pension System."

The Executive Board recommends the APPROVAL of Amendment 2.

Amendment 3

Article III, Section 1b – Membership - [Change the wording to correct an incorrect title]

"Maryland State Teacher Retirement/Pension System to Maryland State Retirement and Pension System."

The Executive Board recommends the APPROVAL of Amendment 3.

Amendment 4

Article III, Section 2a – Membership - [Delete the entire section as it is inaccurate]

"Associate Membership may be accorded, upon payment of dues; to current employees en-rolled in the Maryland State Teachers Retirement/Pension System and their spouses."

The Executive Board recommends the APPROVAL of Amendment 4.

Amendment 5

Article V, Section 1h – Duties of the Officers, the President - [Add: Change the wording to reflect a later proposal that the President serves a two year term.]

"Serve as Past President one year beyond the two consecutive years as President."

{{The Executive Board does not feel the President should serve a two consecutive year term.}}

The Executive Board recommends that Amendment 5 NOT BE APPROVED.

Amendment 6

Article V, Section 2a – Duties of the Officers, the Immediate Past President [Change the wording to correct an incorrect alignment]

"Be the Chairperson of the Nominating Committee for the election of officers."

The Executive Board recommends the APPROVAL of Amendment 6.

Amendment 7

Article V, Section 2b – Duties of the Officers, the Immediate Past President [Add new duties to the office of the Immediate Past President]

"In an emergency situation, the Immediate Past President shall preside at meetings of the Association, the Executive Committee and the Board of Directors."

{{ This organization does not have a Board of Directors and this amendment does not address the President– Elect 's availability.}}

The Executive Board recommends that Amendment 7 NOT BE APPROVED.

Amendment 8

Article V, Section 2b – Duties of the Officers, the Immediate Past President [Add: Clarification of the duties of the Immediate Past President in the absence of the President and the President-Elect]

"In the event that the President and the President-Elect are unavailable, the Immediate Past President shall preside at the meetings of the Association and assume the powers designated, and perform the duties of the President."

The Executive Board recommends the APPROVAL of Amendment 8.

Amendment 9

Article V, Section 3a – Duties of the Officers, the President-Elect - [Add: Change the wording to reflect a later proposal that the President serve a two year term.]

"The President-Elect shall begin serving at the start of the President's second term."

{{ The Executive Board does not feel that the President should serve a two consecutive year term.}}

The Executive Board recommends that Amendment 9 NOT BE APPROVED.

Amendment 10

Article IX, Section 1 – Elections - [Change: The term of office of the President is changed from one to two years.]

"The term of office of the President shall be two (2) consecutive years. Elections and Installation of the President shall be held in May every other year. The President will serve one year beyond the two consecutive years as Past President."

{{The Executive Board does not feel that the President should serve a two consecutive year term.}}

The Executive Board recommends that Amendment 10 NOT BE APPROVED.

Amendment 11

Article IX, Section 2 Elections - [Change: The term of office of the President-Elect is changed from one to two years.]

"The term of office of the President-Elect shall be two (2) consecutive years. The election and installation of the President-Elect shall be held in May at the start of the second year of the President's two-year term."

{{If approved as written, there would be a conflict between the terms of the President and President-Elect.}}

The Executive Board recommends that Amendment 11 NOT BE APPROVED.
